The PIR Swap meet reserves the right to exclude without any recourse any person or items, which violate the following rules, or are otherwise deemed objectionable.

1. **Only automotive related items are acceptable at the PIR Swap Meet.** The following items are not acceptable: food & beverage sales; flammable gasses, liquids or solids; knives; guns or pornography.
2. Applications for stalls are processed on first come-first assigned basis. **Returning vendors have until November 30, 2016 to renew and pay for the same space as the prior year. Prices go up December 1.**
3. **Vendors who are placed on the racetrack must provide a tarp to cover their space to prevent oil spillage.**
4. Your Vendor Parking Permit is to be used for any vehicle that needs “in and out” privileges during the event hours. Vehicles remaining in your vendor stall do not need a Parking Permit. Your Vendor parking permit allows you to park in your stall, or a designated vendor parking area – it does not allow you to park for free in the paid public lots.
5. All vendors must **wear** a vendor wristband to be allowed entry.
6. Vendors will be admitted beginning at 6am daily. There will be no vehicle traffic on the track after 10:00 am whatsoever! Vehicles may enter the track only between the hours of 6AM and 10AM and 5:30PM and 9PM.
7. **ATV's/Quads and motorcycles (regardless of size) are not allowed on the track whatsoever. Golf carts, personal mobility scooters, electric vehicles (other than cars) and non-motorized transportation are still permissible. The speed limit on the track is 5mph.... if you are caught violating the speed limit your “vehicle” will be removed from the premises immediately.**
8. Vendors will receive two vendor passes with each vendor stall rented. Additional passes may be purchased for \$10 in advance and \$15 on-site.
9. Cancellation of vendor space will be accepted by February 1 for a 100% refund; cancellations received between February 1 and March 15 will result in a 50% refund. After that date no refund will be provided. If you are not able to occupy your space, please let us know so that we may fill your space.
10. Alcohol is not allowed to be brought on the Portland International Raceway grounds at any time.
11. Overnight camping is permitted in your vendor stall, or in the campground outside the Swap Meet grounds.
12. Overnight security is provided; however do secure your belongings. PIR is not responsible for any loss or damage.
13. There will be no parts-pick up on the track during the hours the event is open to the public. Those needing to pick-up parts or vehicles will be directed to the parts-pickup area through the main gate.
14. Pets are allowed – but they must be leashed at all times and you are required to pick up after it.
15. Any person causing damage to the racetrack or its grounds will be held financially responsible!
16. Sunday is now a move-out day – All vendors must be out by Noon on Sunday.
17. P.I.R. is a “Drone Free” Zone!
