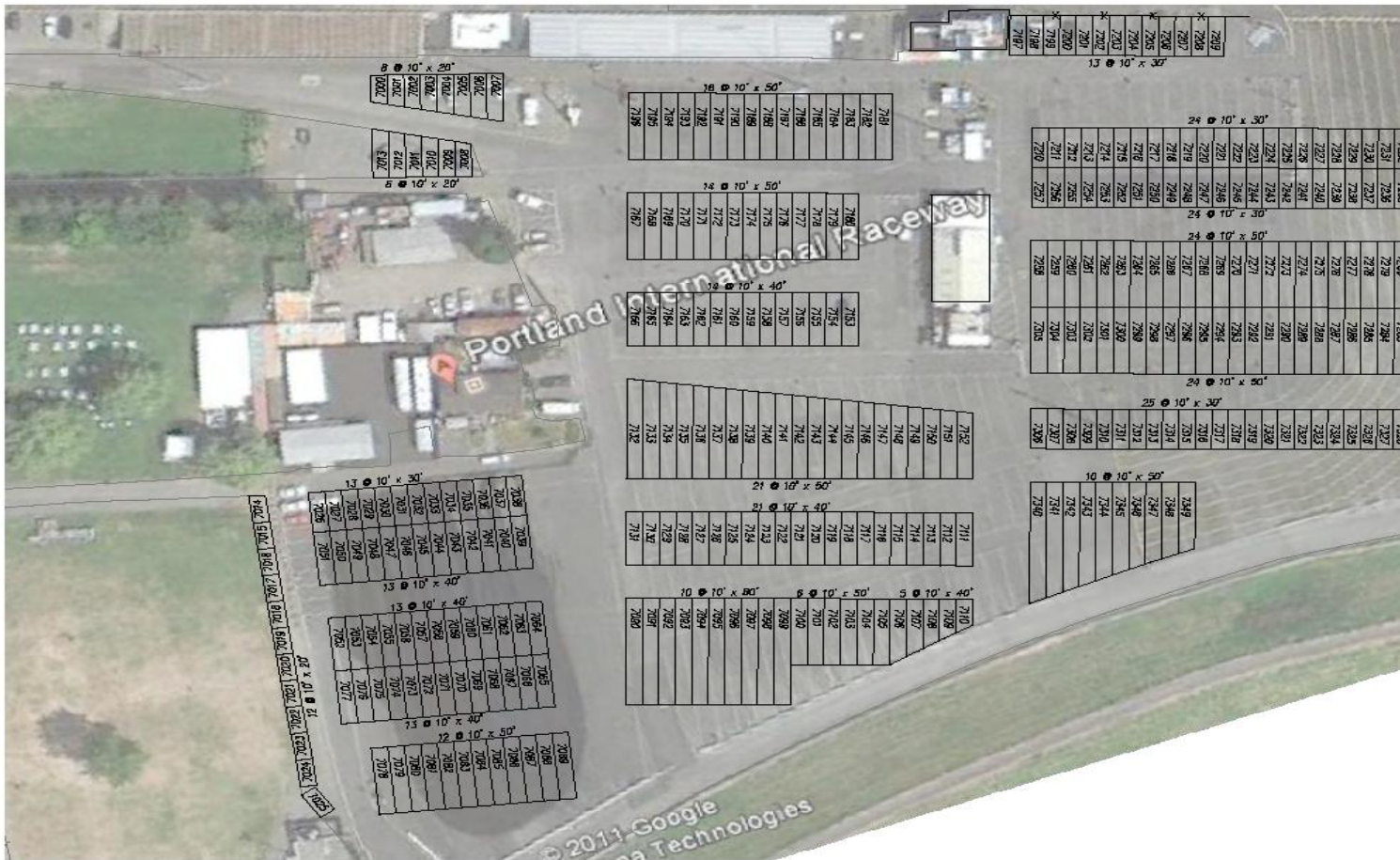

The PIR Swap meet reserves the right to exclude without any recourse any person or items, which violate the following rules, or are otherwise deemed objectionable.

1. **Only automotive related items are acceptable at the PIR Fall Swap Meet.** The following items are not acceptable: food & beverage sales; flammable gasses, liquids or solids; knives; guns or pornography.
2. Applications for stalls are processed on first come-first assigned basis. For 2014 the Fall Swap Meet will be located in the South Paddock of the racetrack – not on the track itself.
3. Your Vendor Parking Permit is to be used for any vehicle that needs “in and out” privileges during the event hours. Your Vendor parking permit allows you to park in your stall, or a designated vendor parking area – it does not allow you to park for free in the paid public lots.
4. All vendors must **wear** a vendor wristband to be allowed entry.
5. Vendors will be admitted beginning at 6am daily. There will be no vendor move-in after 9am.
6. ATV's/Quads and motorcycles (regardless of size) are not allowed. Golf carts, personal mobility scooters, electric vehicles (other than cars) and non-motorized transportation are still permissible.
7. Alcohol is not allowed to be brought on the Portland International Raceway grounds at any time.
8. Overnight camping is permitted in your vendor stall. Please turn generators off by 10pm..
9. Overnight security is provided; however do secure your belongings. PIR is not responsible for any loss or damage.
10. Pets are allowed – but they must be leashed at all times and you are required to pick up after it.
11. Any person causing damage to the racetrack or its grounds will be held financially responsible
